CLIENTS HAVE ACCESS TO HOT SHOWERS, CLEAN CLOTHING, SHOES, LAUNDRY SERVICES, RESTROOMS, TELEPHONES, AND A COMPUTER LAB. ADDITIONAL SERVICES INCLUDE HAIRCUTS, MAIL DELIVERY, AND ASSISTANCE WITH OBTAINING FOOD STAMPS, BIRTH CERTIFICATES, AND LEGAL IDENTIFICATION. THE DAY RESOURCE CENTER'S BIKE SHOP ALSO PLAYS A KEY ROLE IN PROVIDING OPPORTUNITIES BY REPAIRING AND DISTRIBUTING BIKES TO NEARLY 700 CLIENTS ANNUALLY, HELPING THEM IMPROVE MOBILITY AND ACCESS TO RESOURCES.
